Most important were the revival of economic growth and the reduction of poverty. Another significant phenomenon was impact of international crises on Latin American countries. This book analyzes what happened between 1990 and 1999 and revisits issues of interest to ECLAC, using the same approach that has characterized the Social Panorama of Latin America. Analysis begins with a look at poverty, income distribution, employment, occupational stratification, the role of education, the intergenerational transmission of opportunities for achieving well-being and the contribution of social spending to the improvement of the population's standard of living and at interrelationships between these dimensions and economic growth. Where can homebuilders most feasibly seek solutions to problems such as inadequate road infrastructure, a lack of recreational areas, or poor safety conditions? Which problems should government authorities address first, in light of their impact on the well-being of various groups of individuals and given private actors abilities to respond? Which homeowners benefit the most from public infrastructure or services? When can or should property taxes be used to finance the provision of certain services or the solution of certain problems? 'The Quality of Life in Latin American Cities: Markets and Perception' proposes a monitoring system that is easy to operate and that entails reasonable costs but also has a solid conceptual basis. Long the ideal of many scholars and practitioners, such a system may soon become a reality and have the potential to make a significant contribution to the decision-making processes in any city concerned with the well-being of its residents.

Whatever your position on distributed leadership, and you cannot fail to have one, it is irrefutable that distributed leadership has become the leadership idea of the moment. Yet, it is an idea that can be traced back as far as the mid 20s and possibly earlier. So why the interest? limitations of existing structural arrangements to secure organizational growth and transformation (Fullan et al., 2007; Harris et al., 2008; Chapman et al., 2008). As a consequence, many heads and principals are actively restructuring, realigning and redesigning leadership practice in their school (Harris, 2008). While the terminology to describe such changes varies, the core principle is one of extending or sharing leadership practice. While scholars have long argued for the need to move beyond those at the top of organizations in order to examine leadership (Barnard, 1968; Katz and Kahn, 1966) until relatively recently, much of the school leadership literature has tended tofocusupontheheadortheprincipal.
